AMTA VETERANS SERVICE OFFICER

ust some friendly advice from the AMTA Veterans Service Officer (VSO). We have been experiencing some serious cost of living increases this last couple of years and does not seem to be getting any better, any time soon. I strongly recommend, any of us that have a service-connected disability, that may have gotten worse over the years, get it reevaluated. You could possibly receive an increase in tax free income. You can do this a couple of different ways. One is by either providing documentation from a non-VA source, such as a family doctor, or by requesting a reevaluation by the VA facility near you. If you have held a rating for 10 or more years, that rating can not be reduced if you request a reevaluation and the condition hasn't gotten worse. If your disability ratings are related to Agent Orange exposure in Southeast Asia, please check on Patient Aligned Care Team (PACT) benefits. Another recommended suggestion is for all veterans that are not currently enrolled in VA Healthcare, many changes are likely to take place as far as the availability of access to the future use of this important benefit. If you are eligible and haven't enrolled, 2024 is the time to take action. Do this in lieu of thinking you may never need this care in the future. You may never need it, but it is better to have it and not need it rather than to need it and not have it.

years. The AMTA Secretary and AMTA Treasurer. We have two new board members starting in 2023. New board members have some learning to do in order to pick up small tasks that need to be done. The new AMTA president is a standup guy and is willing to work with anyone to get the job done. He refuses to fail at his new job. The AMTA desperately needs an AMTA Membership Chairman. We presently have a co-chairman, but so far no chairman, hopefully someone will take that position when asked to do so by the AMTA President. Another extremely simple task that needs to be done is an editor for the AMTA Newsletter (the WireBender). We have AMTA board members that can do this small task and we are lucky enough to have an AMTA member that is guite proficient in the newsletter business, and willing to help anyone learn. The AMTA President is aware of this need and will be asking someone to pick up this simple task.

The AMT arena most of us are familiar with has essentially faded into history. The lineage of AMT membership is about seventy-five years young. About 52% (76) of the AMTA members are 80 years of age or more. 34 of the AMTA members are between 75 and 79 years of age. That only leaves the AMTA with 33 members less than 75 years of age. Even the youngest of us are now in their sixties. We have four members that are 90 or more. We have one AMTA member under 60 years of age. I ask every AMTA member to participate to the degree they can do so comfortably. We have far more AMTs out there that are not members, than we have as members and I would also solicit efforts to contact them about the AMTA. Tell them about the reunions and they DO NOT have to be an AMTA member to come to the reunion with five guests. We have had many nonmembers to attend an AMTA reunion and join the AMTA while attending. If the AMTA Membership chairman asks for your help, do not refuse the request, as the chairman cannot do the job alone.

I believe we have airborne platforms where the flight crew still includes a maintenance technician of whatever discipline, such as Compass Call. Though these entities may be small and dispersed, they should not be overlooked. If you have information about them or contact with them, please make it known, regardless of your position. It is common knowledge that many recon platforms are built by L-3 Com and L3/Harris. Does anyone have insight on these platforms? We have seventeen members between the ages of 60 and 65. That is almost two generations
